If electronic verification of identification cannot be confirmed using any credit reporter satisfactory to You, additional identification documentation to the standard required will be requested to enable any application for credit to be processed.
2. **Disclose Personal Information for AML Purposes:** You are also authorised to disclose my Personal Information obtained by You pursuant to this consent to any person or organisation to whom you may or must disclose it under the AML Laws or any other applicable laws, including to any credit reporter in order to assist them to provide identity verification information to their customers, and I consent to and authorise any such credit reporter or other person also disclosing my Personal Information to their customers for those purposes.
3. **Hold Personal Information for AML Purposes:** You and any person or organisation to whom you are permitted to disclose my Personal Information may hold it in any manner permitted by the Privacy Act for so long as You or they are required to do so in order to comply with the AML Laws or any other applicable laws.

4. **My Right of Access to Information You Hold:** I understand that I have the right to access, and to correct, Personal Information held by You pursuant to this consent.
5. **Voluntary Signing:** I understand that I am under no obligation to sign this consent or to provide You with any Personal Information (including any drivers licence information we may give You), and I do so voluntarily.
6. **Consequences of Not Signing:** I also understand that failure by me to provide You with this consent may result in You declining any application to You for credit in connection with which You have requested me to provide this consent, and/or the provision of related services provided by You.
